Garbage & Recycling schedules will not be affected over the Christmas Holidays this year.

GARDEN REFUSE/ LEAF PICKUP

The **Chesley Landfill** located at 230 4th St SW will be open from 8am-12pm every Saturday in October & November for leaf drop.

Two bins are located at 281 Alma Street in **Paisley**. They are clearly marked Compost & Brush.

The Arran Landfill located at #671 Sideroad 20 in **Arran** is open every Thursday from 8am-3pm & every Saturday from 8am-12pm year round for leaf drop off free of charge.

*If leaves are *not* in brown paper bags, please dump them out of your container onto the leaf pile at landfill sites, and compost bins.

For those *in urban centres* unable to attend the landfill sites for leaf drop off the Municipality will be picking up leaves on Tuesday October 30th & Tuesday November 13th.

Leaves *must* be in BROWN leaf bags. If you require this service you are required to call the Municipal Office in advance of the date. 519-363-3039 ext #102.

Municipal Office Holiday Hours The Municipal Office will be closed from December 24th – until 8:30 am on January 2nd 2019.

Any payments to be made can be put into the drop box at the front of the office, and will be processed January 2nd 2019 without penalty.

DOG TAGS 2019

All dogs must be registered within the Municipality of Arran-Elderslie. A dog tag must be affixed to the dog's collar at all times. If you get a new dog please come into the Municipal Office to register your dog and to purchase a permanent tag for a fee. If your dog is already registered with a permanent dog tag you will receive an invoice in January. If you pay the invoice by March 31st the fee is \$15.00. If you pay the invoice after March 31st the fee will be increased to \$25.00. Should you require a replacement tag, they are available at the municipal office for a nominal fee.

It is your responsibility to notify us if there is any change to your pet's information.

Parking and Snow Removal

In accordance with by-law 43-08 no vehicle shall be parked on any street in the Municipality between the hours of 2am-7am inclusive between November 1 and March 31. Residents are asked not to put snow on or across roadways as this may cause a dangerous build up of snow and ice.

Parking of vehicles on roads maintained Bruce County **Highways** Department is prohibited between the hours of 1-6am from November 1, to April 1 for snow clearing by by-law 3057 and HTA RSO 1990 and may be towed at the owner's expense. Neither the county, nor the snow plow operators will be held responsible for any damages to property such as fences, mailboxes etc. deemed to be on county road allowance. The depositing of snow or ice on Bruce County roads is also prohibited by by- law 82-2630. Upon conviction of an offense, a fine may be imposed pursuant to the Provincial Offenses Act.

GARBAGE REMINDER: All Bags must be at the curb by 7:00 am.

Two bags of household garbage will be picked up. Bags containing anything other than household garbage will not be picked up. Bag tags for additional bags may be purchased at the Municipal Office, Chesley Convenience, Tara General Store, Paisley GOCO, Paisley Freshmart & Aikens Home Hardware in Allenford for \$3/tag.
